



Fund Overview

The Bluerock Total Income+ Real Estate Fund ("TI+" or "Fund") is a public, closed-end interval fund utilizing a multi-manager, strategy, and sector approach. The Fund allows individuals to invest in institutional private equity real estate (iPERE) securities alongside some of the nation's largest endowment and pension plans. TI+ seeks to provide:

- + Income
- + Access to top-ranked fund managers
- + Lower volatility and correlation to the broader markets
- + Daily pricing at Net Asset Value (NAV)
- + Capital appreciation and diversification
- + Quarterly liquidity**




Capital Appreciation


Performance Metrics (Since inception through 12.31.2016)

Lower Volatility Measured by Standard Deviation




Standard deviation measures fluctuations in daily price changes. A lower number indicates smaller daily price changes.

Higher Risk-Adjusted Return Measured by Sharpe Ratio



A higher Sharpe Ratio indicates that the investment has a higher return per unit of risk.

Lower Maximum Drawdown



Maximum drawdown is the maximum decline a security experiences prior to reaching its previous peak.

The total annual fund operating expense ratio, gross of any fee waivers or expense reimbursements, is 2.46%, 3.25% and 2.24% for Class A, C and I Share, respectively.




Geographic Diversification





Definitions of Selected Indexes

MSCI US REIT Index (Public REITs): A free float-adjusted market capitalization weighted index comprised of equity REITs that are included in the MSCI US Investable Market 2500 Index, with the exception of specialty equity REITs that do not generate a majority of their revenue and income from real estate rental and leasing operations. The index represents approximately 85% of the US REIT universe (www.msci.com). Returns shown are for informational purposes and do not reflect those of the Fund. Barclays U.S. Aggregate Bond Index: A broad-based flagship benchmark that measures the investment grade, US dollar-denominated, fixed-rate taxable bond market. The index includes Treasuries, government-related and corporate securities, MBS (agency fixed-rate and hybrid ARM pass-throughs), ABS and CMBS (agency and non-agency). Provided the necessary inclusion rules are met, US Aggregate eligible securities also contribute to the multi-currency Global Aggregate Index and the US Universal Index, which includes high yield and emerging markets debt. S&P 500: An index of 500 stocks chosen for market size, liquidity and industry grouping, among other factors. The S&P 500 is designed to be a leading indicator of U.S. equities and is meant to reflect the risk/return characteristics of the large cap universe (Investopedia).

Standard Deviation: The standard deviation of the daily percentage change in an investment. Standard deviation shows how much variation from the average exists with a larger number indicating the data points are more spread out over a larger range of values.

Sharpe Ratio: Measurement of the risk-adjusted performance. The annualized Sharpe ratio is calculated by subtracting the annualized risk-free rate - (3-month Treasury Bill) - from the annualized rate of return for a portfolio and dividing the result by the annualized standard deviation of the portfolio returns.
